Nrog rau xyoo kawm ntawv pib tshiab, Wayne County Tus Kws Lij Choj Lub Chaw ua haujlwm tau txhawb txhua tus niam txiv/tus saib xyuas kom sib tham nrog koj cov menyuam hnuv nyoog kawm ntawv hais txog qhov teeb meem uas tau dhau mus, dhau, uas yog kev hem kom ua phem rau tsev kawm ntawv.

Raws li kev tua tsev kawm ntawv ib ntus tau dhau los ua kev txhawj xeeb nyob thoob plaws lub tebchaws, cov xwm txheej no tau tshaj tawm hais hauv xov xwm thiab kev tshaj xov xwm. Qhia peb tias kev tshaj tawm ntawm cov tsev kawm ntawv tuav cov xwm txheej no feem ntau ua rau cov tub ntxhais kawm me ua qhov kev hem thauj zoo ib yam rau lawv lub tsev kawm ntawv, kws qhia ntawv, lossis cov phooj ywg hauv chav kawm. Muaj ntau qhov xwm txheej no, tus tub ntxhais kawm uas ua rau muaj kev hem thawj qhia rau cov neeg tshawb nrhiav hais tias lawv "tsuas yog tso dag." Feem ntau lawv ua qhov kev hem thawj xav tias nws tsis yog qhov teeb meem loj tsuav lawv tsis npaj yuav ua nws tiag. Ib tsab cai lij choj tshiab tau tsim xyoo tas los hais tiam yog hem ib qho kev phem rau cov menyuam kawm ntawv los yog cov neeg ua huaj lwm, ua nyob hauv cheeb tsam ntawm lub tsev kawm ntawv. Cov kev ua txhaum cai no tuaj yeem ua rau raug txim ntau txog 10 lossis 20 xyoo nyob rau hauv tsev lojcuj rau ib tus neeg laus. Nco ntsoov hais tias coob tus menyuam kawm lawv xyoo xaus yog 17 xyoo rau sau, peb lub xeev Michigan suav hais tias yog neeg laus lawm. Lub txhim no yuav muaj teeb meem rau tus menyuam kev txais nyiaj pab kawm ntawv qeb siab thiab, xpoo cov nyiaj ua pab kawm ntawv, thiab tsev kawm ntawv yuav tsis txais lawv, thiab thaum lawv mus nriav haujlwm lawv yuav tau qhia tej kev ua txhaum rau.
